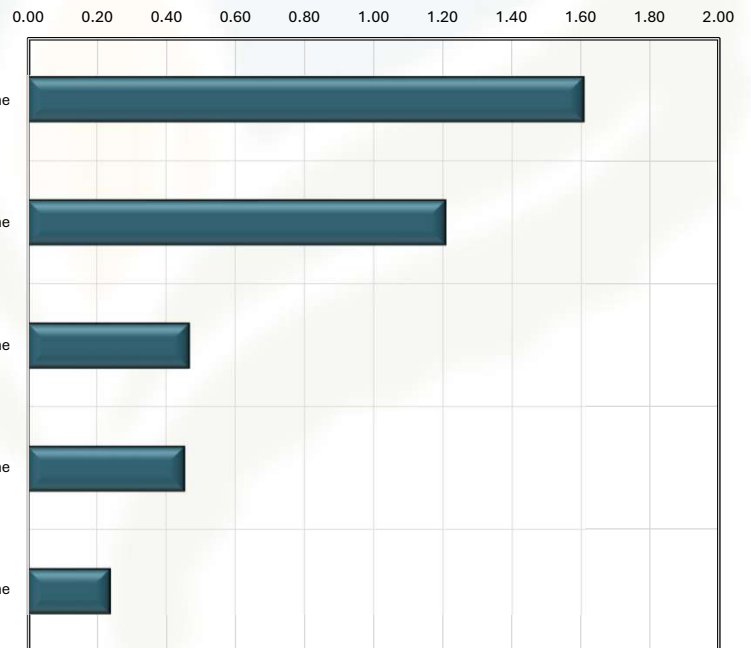
Cannabinoid Ratio (mg/g)
